### FROM THE EDITOR

So far, year 2001 is following the prediction that we will experience a year similar to that of 1947. The government of the day seem to have dealt more swiftly and efficiently with their Foot and Mouth outbreak than the people in charge today. The swarming period has started and beekeepers have reported a number of swarms in the last week of May.

Swarm collection! It has come to notice that some beekeepers are advising that swarms are removed as a public service without charge, it is said to have also happened in our own Federation area. One person (not one of ours) after giving this advice refused to remove a swarm because his hives were full. It was left to a pest control officer who called in a beekeeper who did make a charge. I will guarantee that once these people have filled their hives and collected easy swarms, they will leave it to the genuine beekeepers to do the dirty work, particularly at the end of the season. Some of these do not really want these swarms and but collect them to avoid them "going feral", it is only fair for them to at least recover the cost of their transport. If swarm collectors do not wish to be paid, they could at least obtain a donation toward some deserving fund.

On applying to put my name forward for a refresher course on foulbrood, I found that the local one-day-course organized by BFA was already over-subscribed. This is good news; It is a shame that there is so much apathy within our own Associations, the few "Apiary Tours" that have been organized (with difficulty) have been a great success, some resulting in the discovery of foul brood. Perhaps we could follow the BFA example.

For those with access to a computer, the Apimondia Treatise of Apitherapy will shortly be in your library. I have not yet studied it but I am told that it is very informative.

# THE APIARY IN JULY

Doubtless many of you will have bees that have collected Oilseed Rape in the previous weeks and have by now extracted it I hope! If you haven't, it will now have set rock hard in the comb and the comb will have to be cut from the frame and the whole lot melted down in the Pratley tray.

You may have heard people say this is an undesirable crop, so let's discuss this further. Yes it does granulate rapidly, and needs to be extracted as soon as possible. Yes it granulates rock hard and will bend a spoon quicker than Uri Geller can, but it does so with a fine crystal structure. It also produces a lot of froth during the extracting process, and clogs up your filters. As the froth contains moisturized air, it will raise the water content and may lead to fermentation. Although fermented honey will be edible it will be unpalatable and is un-saleable.

However I like this crop and so do my customers apparently. At extracting time I pass it through a wire filter. This will clog from time to time and is freed by scraping the granulation out with a spoon to allow the honey to continue to percolate through. It is then poured into a settling tank fitted with honey tap, and left overnight. In the morning I remove the froth, then pour it into food grade polythene buckets fitted with lids, holding 30 lbs. of honey, (these are available from the appliance dealers). It is then left for several months and is allowed to granulate.

My warming box is a tea chest insulated with straw, heated by a 40watt lamp, and fitted with a thermistor which will regulate the temperature by switching the lamp 'on' and 'off continuously (This I purchased from The Shop on the Bridge, Oxford Road, Reading).

The 'summer honey' is completely liquidized by setting the thermistor on 'Full' for 24 hours. For the seed honey, (the granulated honey), the thermistor is turned down such, that the lamp is switched 'on' and 'off for the same periods of time. This will produce soft granulated honey after about 48 hours. After it has been stirred with a paint stirrer fitted to an electric drill, it will become pourable and can be added to the 'summer' honey. Both are then stirred together so that they are well mixed. Be careful not to introduce air into this mixture. It is then ready to be poured into honey jars, and will soft set in about a week to nice honey with a fine grain structure. This sounds a complicated process but it is much easier to carry out than it is to describe the method.

# £7.50 –Third (and last) report from the BBKA ADM.

Despite what I have written in the first two articles on the ADM we did get a few decisions taken:-

- 1) Surrey wanted BBKA to get the Ministry to update the disease information on its website weekly rather than quarterly –this was agreed.
- 2) Surrey also wanted the Ministry to accelerate research on bee viruses also agreed.
- 3) Berks wanted the BBKA to tackle the increase in EFB by developing and co-ordinating the Disease Contact role. This sort of thing seemed to us just what the BBKA was there for. The meeting, however, felt that each Association should deal with its Regional Bee Inspectors in its own way and the proposition was thrown out.
- 4) Yorkshire wanted the BBKA objective in the Constitution to include professional as well as amateur beekeepers –passed.
- 5) Harrogate wanted a substantial increase in the cash spent by the BBKA on research and education failed. Props. Requiring unspecified large spends always fail.
- 6) Harrogate also wanted each module of the beekeeping exams to be examined annually rather than every other year –failed. There are not enough people taking the exams to justify the expense.
- 7) Avon and Yorkshire wanted the Open Forums to continue and the meeting agreed. There was a long and heated argument –entirely unresolved –as to who should pay the expenses of Associations who travel long distances to the Forum.
- 8) Leicestershire wanted the BBKA to send its newsletter directly to members (at an undefined extra cost) OR by the present method at the choice of Associations. This was passed. If Berks opts for direct mailing we will have to give individual members addresses to the BBKA, a thing we are required to do anyway.
- 9) Yorkshire wanted the BBKA to be more aggressive on environmental issues and join forces with likeminded organisations such as the RSPB. This was also passed.
- 10) Bucks wanted to charge non-BBKA members more for the use of BBKA facilities and services than members. This was remitted to the Executive for an evaluation of its practicability. They didn't seem keen.
- 11) Kent wanted statutory powers to require pest control companies to keep records of honeybee destruction –passed.
- 12) Norfolk required Associations to examine the role of the BBKA Executive to improve the efficiency and National standing of the BBKA –whatever that meant. Passed with a large majority, so we'll have it on the Council agenda some time. South Chilterns please note, perhaps a more specific proposition from you next year!
- 13) Norfolk also wanted Associations to publish supporting information to make ADM propositions much clearer (they could have started with item 12). This would involve an enormously increased amount of ADM paperwork and, in my opinion (I have to read it all) there is enough already! Nevertheless it passed.

14) Finally Yorkshire wanted to completely overhaul the BBKA Constitution – 2 years after the job was last finished. Since this proposition was accepted by the Executive in advance it was not debated and will happen. I tried to protest, but at the end of a long hard day the rest of the delegates were too tired to show any interest.

When you have a minute, look through these propositions and make up your mind how many of them will move beekeeping forward!

## BBKA Annual Delegate Meeting 2002.

This will be held in January next year so we have to agree any propositions from Berks at the August Federation meeting. If you wish me to bring anything up please get an outline in to Sandra Napper by the 1<sup>st</sup> of August, or discuss it with me, if you wish. We already have three tentative propositions which you might like to comment upon. Remember, it is only really practicable for a county to put up two propositions, so we will need to choose the two most beneficial to beekeeping as a whole.

- In view of the ease and cheapness of communication by Email, Berks propose that the BBKA establish a list of contacts in each affiliated Association. These contacts to administer routine communication between the BBKA and Associations and also the distribution of the BBKA newsletter.
- 2. In view of the long timescale involved in the current ADM formal procedures Berks request the Executive to use its website to advance its policies and seek grass roots opinion
- 3. Berks require the Executive to cease accepting ADM propositions as policy without debate at the ADM or similar forums. This establishes an undemocratic practise of deciding policy without reference to the membership.

The moral here is that it is recommended you should have at least three supers available for each colony you have. I must write a hundred lines, 'I must not open queen cells over an open hive!' Thank you Peter for allowing us to look at your bees, and your wife for providing us with cakes and drinks.
